Table (A): Fees collected from vessel owners or agents

1 Port or Harbor Fees

Item No.	Description	Rate in riyals	Unit
1.1	Port Entry Fee	1000	for each visit by a vessel
1.2	Port Exit Fee	1000	for each visit by a vessel
1.3	Waste Disposal Fee	100	for each vessel per day or part thereof
1.4	Passenger Departure Fee	50	for each passenger

Notes:

- The waste disposal fee specified in item (1.3) of Table (A) shall be collected regardless of whether or not the vessel benefits from such service.

Exemptions:

- The following vessels shall be exempted from the port fees specified in items (1.1), (1.2) and (1.3) of Table (A):
 - o Any vessel with a net tonnage of less than 150 tons.
 - o Sailing ships, dhows, and launch barges (boats).
 - o Fishing and excursion boats unless they occupy space on a commercial berth.
 - o Tugboats, barges, rigs, launches, and other vessels the operation of which under ordinary conditions does not require going beyond territorial waters, unless they occupy space on a commercial berth.
 - o Military vessels.
 - o Fishing boats operating in high seas if they occupy space on a commercial berth.
- Travelers for Hajj and Umrah shall be exempted from the fees specified in item (1.4) of Table (A).

Table (B) First: Tariffs collected from vessel owners or agents

1 Tariffs for Maritime Services

1.1 The Tariffs of pilotage, mooring services, rope handling, and vessel traffic services, including the use of tugboats, line-handling boats, and pilotage launches, shall be applied to each vessel in the following cases:

- Arrival at the port.
- Departure from the port.

This shall be based on the vessel gross tonnage as follows:

Item No.	Description	Rate in riyals	Unit
1.1.1	500 tons or less	2500	
1.1.2	More than 500 up to 3000 tons	1.15	per ton
1.1.3	More than 3000 up to 15000 tons	0.17	per ton
1.1.4	More than 15000 tons	0.10	per ton

1.2 Half the Tariffs specified in item (1.1) of Table (B) First shall be collected for transferring the vessel from one berth to another within the port upon the request of the vessel owner or the agent.

1.3 Collecting Tariffs for the vessel's use of the berth based on vessel's gross tonnage, shall be as follows:

Item No.	Description	Rate in riyals	Unit
1.3.1	500 tons or less	500	per day or part thereof
1.3.2	More than 500 up to 3000 tons	1000	per day or part thereof
1.3.3	More than 3000 up to 15000 tons	1500	per day or part thereof

Table (B) First: Charges collected from vessel owners or agents

1.4 Tariffs for the vessel's use of anchorage area, based on the vessel's gross tonnage, shall be as follows:

Item No.	Description	Duration of stay at anchorage area	Cost in riyals	Unit
1.4.1	3000 tons or less	less than 48 hours	250	per day or part thereof
1.4.2	More than 3000 tons	less than 48 hours	500	per day or part thereof
1.4.3	3000 tons or less	More than 48 hours	1000	per day or part thereof
1.4.4	More than 3000 tons	More than 48 hours	2000	per day or part thereof

Notes:

- The vessel's gross tonnage is the gross registered tonnage (GRT) or gross tonnage (GT). If the vessel uses both, the Tariffs shall be calculated based on the higher figure in accordance with items (1.1), (1.2), (1.3), and (1.4) of Table (B) First.
- The Tariffs specified in item (1.1) of Table (B) First shall be collected whether the vessel receives all the services or part thereof. Vessels that do not require the use of tugboats as part of their service shall be Tariffed half of the specified Tariffs.
- Vessels requiring special treatment due to its inability to use the engines or due to a defect in the rudder or the like shall be charged double the fees specified in item (1.1) of Table (B) First.
- The duration of a vessel's usage of the berth as specified in item (1.3) in Table (B) shall commence from the time of its arrival at the berth and shall end upon its departure therefrom. Every 24 hours or part thereof shall be deemed one day.
- The Tariffs specified in item (1.3) of Table (B) First shall not be collected for the following periods:
 - o A vessel's period of stay at a berth for non-handling operations upon a written request from a government agency.

Table (B) First: Charges collected from vessel owners or agents

- A period of complete halt in handling operations for more than 24 hours for reasons beyond the control of the vessel's owner or agent.
- Regarding the use of the berth area specified in item (1.3) of Table (B) First, any vessel occupying the commercial berth due to the vessel failing to vacate the berth one hour after the port control vessel departure clearance shall be charged 500 SAR per hour. Overstay tariffs shall not include overstays resulting from port operators' errors such as incorrect lashing, damage to the container or vessel structure by the operator, and the like, or as a result of an emergency.
- With respect to item (1.4) of Table (B) First, the duration of a vessel's usage of the anchorage area shall commence from the time it enters the area and ends with its departure therefrom. Every 24 hours or part thereof the vessel occupies the anchorage area shall be deemed one full day.
- The tariffs specified in (1.4) of Table (B) shall not be collected if the vessel remains in the anchorage area due to a lack of space in the berth.

Exemptions:

- The following vessels shall be excluded from tariffs specified in item (1) of Table (B) First:
 - Military vessels
 - Fuel supply vessels, water supply vessels, excursion vessels, fishing vessels, tugboats, service launches, and barges. Half the tariff specified in (1.3) of Table (B) First shall be collected if said vessels occupy space on a commercial berth.

2 Tariffs for loading and unloading cargo between the vessel and the berth (ship-to-dock), excluding transit and transshipment operations

2.1 General Cargo and Breakbulk Cargo

Item No.	Description	Rate in riyals	Unit
2.1.1	General cargo	20	per ton or cubic meter or part thereof, whichever is higher
2.1.2	Exported bagged cement, handled by the owner and his equipment	8	per ton or part thereof

Notes:

- General cargo specified in item (2.1.1) of Table (B) First shall include all cargo,

Table (B) First: Charges collected from vessel owners or agents

except vehicles, self-propelled equipment, livestock, bulk cargo, or cargo loaded onto containers, flatbed trucks, or trailers.

- General cargo requiring special equipment or treatment as part of its handling service shall be subject to the tariffs specified in item (2.1.1) of Table (B) as well as to tariffs for any additional services rendered thereto in accordance with item (3.8) of Table (B) First.
- In case of dangerous cargo, an additional 25% shall be charged over the tariffs specified in item (2.1) of Table (B) First.

2.2 Tariffs for vehicles and self-propelled equipment shall be based on their weight as follows:

Item No.	Description	Rate in riyals	Unit
2.2.1	Less than 3 tons	140	per unit
2.2.2	From 3 to 10 tons	200	per unit
2.2.3	More than 10 and up to 40 tons	540	per unit
2.2.4	More than 40 tons	1350	per unit

Notes:

- Semi-trucks shall be subject to item (2.2) of Table (B) First, and the trailers attached thereto shall be subject to item (2.5.1) of Table (B) First.
- Tracked vehicles must be mounted on trailers or flatbeds and shall be subject to item (2.5.1) of Table (B) First. If such vehicles are equipped in a manner that will not cause any damage to the port, they shall be subject to item (2.2) of Table (B) First.
- Automobiles and self-propelled vehicles which cannot be driven to and from the vessel for any reason, including lack of fuel therein or unsuitability of the vessel, shall be charged three times the amounts specified in item (2.2) of Table (B) First.

2.3 Livestock

2.4 Bulk Cargo

2.4.2	Bulk cargo for port projects handled using their know-how and equipment, including cargo handled on project berth at industrial ports	4	per ton or part thereof
2.4.3	Exported bulk cement and clinker handled using the owner of the cargo' know-how and equipment	1	per ton or part thereof
2.4.4	Oil, gas, and liquid petroleum products handled on designated berth	1	per ton or part thereof

2.4.5 Liquid bulk handled through Ship-to-Ship (STS) transfer operations shall be charged directly by the port at a rate of 1 SAR per ton or part thereof.

2.5 Tariffs for loaded and empty containers, flatbeds, and trailers, whether exported or imported, shall be as follows:

2.5.1 Tariffs for containers, flatbeds, and trailers handled to and from Ro-Ro vessels (Ro-Ro Operations) shall be as follows:

Notes:

- Regarding items (2.5.1), (2.5.2), and (2.5.3) specified in Table (B) First relating to late gate tariffs for export containers gated in after vessel cut-off time shall be charged at 100 SAR per container. The relevant stakeholder shall be notified about the individual cutoff times of terminal operators.
- In case of dangerous cargo, an additional 25% shall be charged over the tariffs specified in items (2.5.1), (2.5.2), and (2.5.3) of Table (B) First.
- Gate handling tariffs for containers specified in item (2.5.4) of Table (B) First shall include inspection and handling to and from trailers and trucks within port yards.

2.6 Prefabricated Houses:

Notes:

- The services covered by ship-to-dock loading and unloading tariffs specified in item (2) of Table (B) First, except for items (2.1.2), (2.4.2), (2.4.3), and (2.4.4) of Table (B) First, the tariffs of which shall be collected for facilitations provided by the port, shall be as follows:

- Covered Services:

- Lashing and unlashings of containers or any other cargo, as required.
- Providing workers.
- Providing auxiliary tools for handling cargo (such as pallets).
- Providing towing heads and forklifts for ro-ro operations.
- Providing specialized cranes for handling containers on container vessels.
- Providing handling equipment for bulk cargo on bulk cargo vessels.
- Counting cargo and preparing reports on the findings thereof.
- Additional working hours.
- Supervising handling operations on vessels and berth.
- Using port barges.

Tariffs shall be collected regardless of whether all or part of the abovementioned services are provided.

- Services Not Covered:

- Any other equipment not covered by the services stated above.
- Handling cargo damaged due to marine accidents. Tariffs shall be collected according to the non-maritime additional services stated in Table (B) First item (3.8).
- Lost time for which the vessel owner or agent is responsible. Tariffs shall be collected according to Table (B) First item (3.5).
- Re-stowage of cargo that belong to other ports on vessels. Tariffs

shall be collected according to Table (B) First item (3.6).

3 Tariffs for ancillary services related to loading and unloading cargo between the vessel and the berth, excluding transit and transshipment

3.1 Vessel owner or agent is responsible for the opening and closing of the hatch cover at his own costs. Any instance of hatch cover handling by the operator shall be charged at 383 SAR per cycle (including hatch opening and closing).

3.2 Vessel owner or agent is responsible for the gearbox lifting at their own costs. Any instance of gearbox lifting by the operator shall be charged at 250 SAR per move (for each gearbox unit and not for bins).

3.3 Any container requiring additional holders for handling shall incur an extra tariff of 300 SAR per unit, whether imported or exported.

3.4 Destuffing, sorting, and stacking the contents of a LCL container or trailer shall be charged as follows:

3.4.1	20 feet or less	850	per unit

3.4.3	Longer than 40 feet	2250	per unit

3.5 Lost time falling under the responsibility of the vessel owner or agent shall be charged as follows:

Table (B) First: Charges collected from vessel owners or agents

Item No.	Description	Rate in riyals	Unit
3.5.1	Container vessels that are unloaded by special container cranes	6300	per crane per hour or part thereof
3.5.2	Ro-Ro and passenger vessels	3000	per hour or part thereof
3.5.3	General cargo vessels and others	500	per each group of workers per hour or part thereof

3.6 Re-stowage of cargo that belong to other ports on the vessel shall be charged the usual transshipment handling tariffs.

3.7 Tariffs for connecting a refrigerated container or trailer to an electric current, supplying it with fuel, and monitoring its temperature shall be 134 SAR per day or part thereof for the first three days from the date of unloading.

3.8 Any other non-maritime additional service, such as cleaning vessel holds, repairing damaged packages of cargo, and handling cargo requiring special equipment or treatment shall be charged, and the party requesting the service shall provide the necessary materials. The actual cost shall be calculated as per the tariffs for used equipment and manpower according to Table (D).

3.9 Any additional maritime service, such as rescue operations, pollution control, fire-fighting, or any other service shall be charged. The actual cost shall be calculated as follows:

- The value of used materials.
- The tariffs for used equipment and manpower according to Table (D).
- The tariffs for used equipment that are not included in Table (D) shall be calculated based on cost of operation, maintenance, and depreciation.

3.10 Security services provided to level 2 security vessels upon their arrival at Saudi ports:

Notes:

- In item (4) of Table (B) First, storage free time for exports is calculated from the date of the arrival at the port, and for imports, storage free time shall be calculated from the day of discharge from the vessel (public holidays shall not be excluded in the calculation of free time). Storage time shall be calculated based on the actual number of storage days.
- In item (4) of Table (B) First, free time shall apply only once to a given container, trailer or flatbed during each passage through the port, irrespective of any change in the relevant user or terminal.

Exemptions:

- In item (4) of Table (B) First, containers, trailers or flatbeds the entry of which is prohibited due to public interest, and which are unloaded within the customs zone and are re-exported empty shall be exempted from the payment of storage tariffs for a period of 13 days from the date on which customs issues a decision permitting clearance of their contents.

5 Tariffs for Passenger Services

Notes:

- The tariffs specified in item (5) of Table (B) First apply to embarking and disembarking passengers, and not to manifested passengers. The vessel's crew is exempted from payment of said tariffs.

Notes:

- General cargo specified in item (1.1.1) of Table (B) Second shall include all cargo, except vehicles, self-propelled equipment, livestock, bulk cargo, or cargo loaded onto containers, flatbed trucks, or trailers.
- The tariffs for port services specified in items (1.1), (1.2), and (1.3) Table (B) Second shall be collected for unloading cargo from vessels and transporting them to transitional areas or storage yards, and stacking it appropriately. They shall then be transferred to customs inspection halls and then to the owners' means of transport. In case of export, the same process shall be followed in reverse, whether all or part of the services are provided.
- The tariffs for port services specified in item (1.4) of Table (B) Second shall be collected for using the port's basic equipment.
- The tariffs for the port services specified in item (1.5) of Table (B) Second shall be collected for transporting containers, flatbeds, and other trailers after unloading them from the vessel to the yard of imported cargo and stowing them, then transporting them to the owners' means of transport for delivery.
- In case of dangerous cargo, an additional 25% shall be charged over the tariffs specified in items (1.1) and (1.5) of Table (B) Second.

Exemptions:

- Cargo imported with re-export duties shall be exempted from the tariffs collected by the port from the owner of the cargo in accordance with item (1) of Table (B) Second. Such tariffs shall be collected upon the entry of such cargo into the Kingdom.

2 Tariffs of handling services for customs inspection

2.1 Tariffs of handling services for customs inspection for imported loaded containers:

Item No.	Description	Rate in riyals	Unit
2.1.1	Containers of 20 feet or less	460	per container
2.1.2	Containers longer than 20 feet	550	per container

Notes:

- The customs inspection service specified in item (2.1) of Table (B) Second shall include:
 - o Transferring containers to the custom's x-ray scanning area using the station's trailers.
 - o Transferring the container to the storage area upon completion of x-ray inspection.
 - o Transferring containers, the customs inspection of which does not require the unloading of its contents, to the delivery area.
 - o The handling tariffs in the event customs release requires the unloading of the contents of the container and reloading them, provided that the cargo is stowed inside the container in a way that permits unloading and reloading the contents mechanically using handling equipment.
- Regarding item (2.1) of Table (B) Second, any instance of container rescanning request due to cargo owner documentation error shall be charged at 540 SAR per container. This tariff shall include Lift-on Lift-off tariffs, transferring containers to the custom's x-ray scanning area using the station's trailers and transferring back the container to the storage area upon completion of x-ray inspection.

3 Tariffs for ancillary services related to the port services for containers, flatbeds and trailers

3.1 Tariffs of container/trailer destuffing or stuffing:
